Sub:- Kerala Forest Department - Establishment - Percentage Higher Grade 1/3 of Fair Copy Superintendent in the Scale of pay of Rs. 35700-75600 - Sanctioned orders issued.

As per G.O. read as 1st paper above 1/3 post of Fair Copy of Superintendent are placed on Higher Grade in the Scale of pay of Rs. 35700-75600.

In Forest Department there are 8 posts of Fair copy Superintendents. As such 3 posts of Fair Copy superintendents have been upgraded as Fair Copy Superintendent (Higher Grade). Consequent to retirement of Smt.K.Santhakumari, Fair Copy Superintendent (Higher Grade) on 31.07.2018 one vacancy of Fair Copy Superintendent (Higher Grade) arose in the department. As per the provisional Seniority list of Fair Copy Superintendents in 3rd paper read above Smt.C.Ramlath, Fair Copy Superintendent is eligible for the promotion as Fair Copy Superintendent (Higher Grade) in the above vacancy.

In the above circumstances, Smt.C.Ramlath, Senior most Fair Copy Superintendent is sanctioned ratio based higher grade promotion in the scale of pay of Rs. 35700-75600 w.e.f. 01.08.2018.

The post held by the offices will stand upgraded to Fair Copy Superintendent (Higher Grade) as long as they continue in the post. As per G.O. read as 1st paper above, Government has interalia ordered (Annexure III) to grant time bound higher grade promotion on completion of 27 years of service in the entry cadre of L.D. Typist in the Scale of Rs. 35700-75600. Those who are already enjoying the fourth time bound higher grade
