**ORDER**

Government of Kerala had framed the Kerala Information Technology (Electronic Delivery of Service) Rules, 2010 vide G.O read as 1 st paper above for the overall governance of the service delivery under the e-District project. Government have further amended the Rules vide Government Orders (Amendment rules) read from 2nd to 4th papers above.

2) Government have already fixed validity of various certificates issued from time to time vide GOs read as 5th, 6th and 7th papers above. Also, the column 'purpose issued for' was removed and the validity was fixed as one year in the case of income certificates vide G.O read as 7th paper above.

3) Vide G.O read as 9th paper above, Government have accorded sanction for the removal of the column 'purpose issued for' from the Nativity and Domicile certificates. Government have further canceled issuing Caste and Community Certificates for a specific purpose and re-fixed the validity period of Caste Certificate for three years as per G.O read as 10th paper above.

4) Government views it necessary to incorporate the above provisions in the output format of e-District project by amending the Kerala Information Technology (Electronic Delivery of Services) Rules, 2010,urgently, so as to alleviate the difficulties caused to the public due to unwarranted provisions in the Rules. As per letter read above, Director, Kerala State IT Mission has furnished a detailed proposal with regard to modifications or amendments in the existing forms.

5) Government have examined the matter in detail and are pleased to order as follows:

(a) In case of applications for Community Certificate, Nativity Certificate, Domicile Certificate, Income Certificate, and Caste Certificate; the field "To be produced before" shall be non-editable and marked "General" in English and "ജനറൽ" in Malayalam. Necessary modifications are to be done in Form 1A.

(b) In Form 1C, "Community Certificate"; Form 5C, "Nativity Certificate"; Form 9C, "Domicile Certificate"; Form 10C, "Income Certificate"; and Form 13C, "Caste Certificate"; the field "Purpose for which the certificate is issued for" shall be omitted.

(c) The field "Validity of the certificate." shall be included in English and "സർട്ടിഫിക്കറ്റിന്റെ കാലാവധി" in Malayalam in Forms 1C to 25C.

d) The Director, KSITM shall make appropriate modifications in the online applications/certificates, according to its type as specified above and also on par with the modifications issued as per GO's referred above.

6) Necessary amendments to the Kerala Information Technology (Electronic Delivery of Service) Rules, 2010 will be issued separately.
