As per G.O read 1st paper above 1/3 post of Fair Copy Superintendents are placed on Higher Grade in the scale of pay of Rs.35700-75600.


In Forest Department there are 8 posts of Fair Copy Superintendents. As such 3 posts of Fair Copy Superintendents have been upgraded Fair Copy Superintendent (HG). Consequent to the retirement of Smt.C.Ramlath, Fair Copy Superintendent (HG) on 30.04.2019 one vacancy of Fair Copy Superintendent (HG) arose in the department. As per the seniority list of Fair Copy Superintendent in 3rd paper read above Smt.D.Ushakumari, Fair Copy Superintendent, O/o Additional Principal Chief Conservator of Forests (Administration), Thiruvananthapuram is eligible for the promotion as Fair Copy Superintendent (HG) in the above vacancy.

In the above circumstances, Smt.D.Ushakumari, Senior most Fair Copy Superintendent is sanctioned ratio based Higher Grade promotion in the scale of pay of Rs.35700-75600 w.e.f 01.05.2019.

The post held by the office will stand upgraded to Fair Copy Superintendent (HG) as long as they continue in the post and the post of Fair Copy Superintendent (HG) in O/o. Chief Conservator of Forests, Kannur will downgrade to Fair Copy

Superintendent. As per G.O read as 1st paper above Government has interalia ordered (Annexure III) to grant time bound Higher Grade promotion on completion of 27 years of service in entry cadre of L.D Typist in the scale of pay of Rs.35700-75600. Those who are already enjoying the fourth time bound Higher Grade promotion (27 years) as above are not eligible for fixation of pay as per rule 28 A Part I KSR based on ratio based Higher Grade promotion granted in this order.

Necessary entries in this regard will be noted in the Service Book of the incumbent.
