**Application for appointment to the post of Director, Indian Plywood Industries Research and Training Institute, Bengaluru-22**

Please refer to the Advertisement dated 13-19 July 2019 in the Employment News/Rozgar Samachar and in the Times of India (all editions) dated 13-07-2019, for appointment to the post of Director, Indian Plywood Industries Research and Training Institute, Bengaluru-22. In this context, it is to inform that the Competent Authority has decided to extend the last date of application to the post of Director, IPIRTI till 30-11-2019 (including North East States). The particulars of the post are given below:

1. **Pay Band and Grade Pay:** Rs.37400-67000: 10000/- (pre-revised) plus allowances as admissible under the Central Government Rules. **An employee on deputation may elect to draw either pay in the scale of pay of the deputation post fixed under the normal rules [FR 22(I)(a)/ (I)(a)(2), etc.], or his basic pay in the parent department from time to time plus personal pay, if any and Deputation (Duty) Allowance.**
2. **Eligibility:** Officers of the Central/State Government/Universities/Recognized Research Institute/Semi-Government or autonomous Organisation holding Analogous Posts on regular basis **OR** with at least 5 years regular service in post carrying Grade Pay or Rs. 8900/- in the Pay band of Rs.37400-67000/- (pre-revised)
3. **Essential Qualification:** (a) First Class Post-Graduate Degree in Physical/Chemical/Life Sciences/Forestry/Agriculture or B.E. (First Class) or Equivalent Degree in Chemical/Civil/Mechanical Production Engineering from a recognized university or AIFC Diploma or Equivalent qualification in Forestry (b) 25 years of experience in the relevant field with at least 10 years administrative research experience in the field of Forestry.
4. **Desirable:** Doctorate Degree in a subject related to Forestry/Forest Products and publications in referred journals.
5. **Age:** Not exceeding 54 years as on the closing date of application.
6. **Terms and Conditions:** (a) Age of superannuation is 60 years (b) The appointment will be by transfer on deputation basis for a period not exceeding 5 years or till the age of superannuation whichever is earlier.

**Note:-**

- (i) In case of Indian Forest Service (IFS) officers in the rank Chief Conservator of Forest (CCF) and Scientist in level 'G' will be eligible to apply for the post of Director, IPIRTI and the conditions of having 25 years of experiences in the relevant field with at least 10 years administrative research experience in the field of forest will not be applicable.
- (ii) The applications of those in the government service must be sent through Proper Channel along with the records of confidential Report and Vigilance Clearance.
