The Kerala Public Service Commission selected and advised the following **25** candidates for the Forest Rangers Course of 2012-2013 vide advice read 1st & 2nd for filling the vacancies of Range Forest Officers available in the Forest Department under the quota earmarked for Direct Recruitment from among candidates who possess a Degree in Forestry.

The above mentioned candidates selected and advised by Kerala Public Service Commission were temporarily appointed as Range forest Officers in the Scale of pay of Rs. 20740-36140 vide the order read as 3rd cited. As per Rule 9 (2) (a) of Kerala Forest Service Special Rules, 2010, the Range Forest Officers appointed by Direct Recruitment under item (i) (a) and (i) (b) and by appointment by transfer under item (iii) (a) and (iii) (b) under category 3 of rule 3 shall undergo 18 months Rangers training in any of the institutions under the Director of Forestry Education, Government of India. Accordingly they were deputed for 18 months certificate course of Forest Range Officers during 2012-13 which commenced from 14.02.2012 at the Andra Pradesh Forest Academy, Dulappally, Hyderabad vide the order read as 3rd cited.

While undergoing 18 months certificate course of Forest Range Officers Sri.Srinivasan.K had got appointment as Assistant Professor in the College of Forestry in Kerala Agricultural University and he was relieved from the Kerala Forest Department vide Order read as 4th cited.

As per Rule 9 (2)(b) of Kerala Forest Service Special Rules, 2010, Range Forest Officers appointed by Direct Recruitment, on completion of training in the institution shall undergo practical training for one year in the Forest Department. Accordingly on completion of Rangers training in the institution the 24 candidates were deputed for practical training for one year in the Department on 12.08.2013 vide order read as 5th cited. On successful completion of practical training, the above said incumbents reported for posting on the AN of 16.08.2014 and they were transferred and posted vide order read as 6th cited.

Meanwhile, Sri.David Camus.D had got selection as Scientist in the Agricultural Research Service (ARS) in Indian Council of Agriculture Research, New Delhi and he was relieved from Kerala Forest Department vide Order read as 7th cited.

In order to regularize the appointment of the above incumbents, the character and antecedents of them were got enquired through the Police Department. Police authorities concerned, vide letters mentioned below informed that the above candidates advised by Kerala Public Service Commission are suitable for appointment in regular Government Service. As such the stipulation made in Rule 10 (b) (iii) of KS & SSR is duly satisfied.

As part of regularization of appointment, the certificates of the above incumbents were verified by the Kerala Public Service Commission and Verification Certificates and Identification Certificates of all of them except Sri. Abdul Jaleel.P was forwarded to this office vide letter read as 8th cited. He hadn't furnished personal memorandum for verification of certificates. So verification of his certificate has not been made so far. Hence his appointment cannot be regularized.

In the letter read as 9th Government clarified that probation in the cadre of Range Forest Officers starts from the date on which the appointee joins duty after successful completion of training prescribed in clause (a) of sub rule 9 of Kerala Forest Service Special Rules, 2010. Therefore, regularization of appointment can be done from the said date. The date of joining of appointee for practical training after successful completion of Rangers Training in the institute is on 12.08.2013.

In the above circumstances, the appointment of the above mentioned **22** Range Forest officers under Rule 9 A (1) of KS & SSR is hereby regularized with effect from **12.08.2013**. The incumbents will be on probation for a period of two years on duty within a continuous service of three years as per Rule 8 (i) of the Kerala Forest Service Special Rules, 2010.
