

Shri.K A Mohammed Noushad IFS (KL:1987) Principal Chief Conservator of Forests (Social Forestry) is due to retire from service on superannuation on 30.04.2019. Shri.K A Mohammed Noushad IFS has to be relieved in the A.N of 30.04.2019. The post of Principal Chief Conservator of Forests (Social Forestry) is an ex-cadre post and the continuance sanction of the said post expires on 30.04.2019. Request for extension of continuation sanction of the post was submitted to Government vide reference cited and formal orders are awaited.

The posts of Conservator of Forests (Social Forestry), Ernakulam/Kollam are also falling vacant on 31.05.2019. Since Social Forestry Wing is gearing up for the World Environment Day coming on 5th June and the retirement of Principal Chief Conservator of Forests (Social Forestry) on 30.04.2019 and Conservators of Forests (Social Forestry) Ernakulam & Kollam on 30.05.2019 will create a vacuum in the Social Forestry Wing at the top level and Regional level, appropriate charge arrangements are to be made..

In the above circumstances, Shri. E Pradeep Kumar IFS, (KL:1991) Additional Principal Chief Conservator of Forests (Forest, Land & Resources) is directed to discharge the functions which Shri K A Mohammed Noushad IFS

was doing as Principal Chief Conservator of Forests (Social Forestry) Thiruvananthapuram until further orders from Government. This is in addition to his duties and functions of Additional Principal Chief Conservator of Forests (FL&R).

This order is issued subject to ratification by Government.
