1. However, the release of vehicles from HQ will be subject to the following:


- Submission of condemnation proposal for the equivalent number of vehicles by the concerned circle and an undertaking that the vehicles proposed for condemnation will be garaged immediately on receipt of replacement vehicles and the process for disposal will be initiated immediately on receipt of condemnation orders.
- There are a few vehicles which were meant for condemnation and disposal on account of the 47 vehicles purchased by the department during 2016-17 FY. The process of condemnation and disposal is seen pending for a few vehicles. The available data base is attached herewith. The release of the new vehicle to the concerned circle will be incumbent upon submission of condemnation proposal for the concerned vehicles and an undertaking that the vehicles have been garaged.

2. The circle officers would decide the further distribution of allotted Thar vehicles to the ranges where it is required and would also decide the subsequent deployment of vehicles being vacated from the ranges (in case not condemned), under intimation to this Office.



3. All the Officers to whom new vehicles are allotted, as per this order, shall make necessary arrangements to sent drivers along with authorization letter addressed to the Assistant Conservator of Forests (Planning) to take delivery of the vehicle from the Forest Headquarters.
