1. The vehicles against which the new vehicles are purchased as mentioned in table – I above should not be used further and should be disposed immediately as per norms. Compliance report, within one month from the date of this order.
2. All the officers, to whom new vehicles are allotted, as per this order (table – I), shall make necessary arrangements to depute a staff along with authorization letter addressed to the Assistant Conservator of Forests (Planning) to take delivery of the vehicle from the Forest Headquarters.
3. The vehicles re-allotted as per table – II of this order can take delivery of the vehicles from the present custodians and report compliance.
4. All officers concerned are requested to make necessary entries in the 'Vehicle Management Module' of KFD.
