**Order No. P3 – 2328 / 2018 dated: 05 - 09 -2018**

As per the reference first cited above, Gol has approved an APO for the utilization of CAMPA fund in which an amount of Rs. 245 lakh has been earmarked for the purchase of new vehicles for field protection. Based on this, vide reference 2<sup>nd</sup> cited Government has accorded Administrative Sanction for the purchase of 21 new vehicles (Thar Non A/C – 16 Nos and Scorpio Getaways - 5 Nos) against condemned vehicles under CAMPA fund during the FY 2018 -19. Accordingly, supply order for the same was placed and the company M/s Mahindra & Mahindra delivered 13 Thar Non A/C vehicles to KFD.

Under these circumstances, I Rajan Sehgal, IFS hereby allot the newly purchased vehicles as shown below with immediate effect.
