As per the Order cited 3rd above, 1 Deputy Range Forest Officer has been temporarily appointed as Range Forest Officer, 1 vacancy arose due to retirement of Deputy Range Forest Officer, 1 vacancy arose due to death of Deputy Range Forest Officer and 1 leave vacancy. Thus 4 vacancies arose in the cadre of Deputy Range Forest Officers.
