IFS
Ex-cadre posts of Additional Principal Chief Conservator of Forests (Wildlife) and Additional Principal Chief Conservator of Forests (Planning) are created in the Scale of Pay of Rs.67000-79000 by keeping in abeyance the cadre post of Chief Conservator of Forests (Wildlife) and Chief Conservator of Forests (Planning) (Now operating as Chief Conservator of Forests, High Range Circle (Kottayam) and Chief Conservator of Forests, Eastern Circle (Palakkad) vide G.O. read as 1st paper above).

2. The post of Additional Principal Chief Conservator of Forests (Wildlife) and Additional Principal Chief Conservator of Forests (Planning) are declared equivalent in status and responsibility to the cadre post of Additional Principal Chief Conservator of Forests (D & P), Tvpm under Rule 11 of IFS (Pay) Rules.

3. The creation of the above ex-cadre posts are for the limited purpose of giving promotion to the officers.

4. The following IFS officers of 1987 & 1988 Batch Kerala Cadre are promoted to the grade of Additional Principal Chief Conservator of Forests in the scale of Pay of Rs. 67000-79000 with immediate effect.

a) Smt.Sobhana Kamala Sudarsana Rao IFS (KL:1987), Chief Conservator of Forests (Special Afforestation & Nodal Officer), Thiruvananthapuram) is promoted to Additional Principal Chief Conservator of Forests grade and posted as Additional Principal Chief Conservator of Forests (Special Afforestation & Nodal Officer), Thiruvananthapuram by upgrading the ex-cadre post of Chief Conservator of Forests (Special Afforestation & Nodal Officer), Thiruvananthapuram.

b) Shri.Bennichen Thomas IFS (KL:1988), Chief Conservator of Forests, High Range Circle (Kottayam) is promoted to Additional Principal Chief Conservator of Forests grade and posted as Additional Principal Chief Conservator of Forests (Wildlife) in the ex-cadre post created vide para 1 above. The officer is allowed to retain his station at Kottayam.

c) Shri N.K.Sasidharan IFS (KL:1988), Chief Conservator of Forests, Eastern Circle (Palakkad) is promoted to Additional Principal Chief Conservator of Forests grade and posted as Additional Principal Chief Conservator of Forests (Planning) in the ex-cadre post created vide para 1 above.

5) The orders regarding proforma promotion of Shri Anirudh Kumar Dharni IFS (KL:1987) and Shri Ganga Singh IFS (KL:1988) will be issued separately.

6. The promotions are ordered with the concurrence of GOI as stipulated under Rule 3(2) (ii) & (III) of IFS (Pay) Rules, 2007 vide letter read as second paper above.
