- IFS
- (i) The first return(as on 1st August,2014) under the Lokpal Act should be filed on or before the 30th April,2015(now been extended upto 15.10.2015 vide DoPT's Office Memorandum No.407/12/2014-AVD-IV(B) dated 25.04.2015);
 - (ii) The next annual return under the Lokpal and Lokayuktas Act,2013 for the year ending 31st March,2015 should be filed on or before 31st July, 2015; and
 - (iii) The annual return for subsequent years as on 31st March every year should be filed on or before 31st July of that year.

I am to request you to kindly intimate the above facts to all IFS officers of Kerala Cadre.
