

As per Order read 1st above Smt. L.Santhakumari, Senior most Selection Grade Typist has been promoted as Fair Copy Superintendant and allowed to continue in the Office of the Additional Principal Chief Conservator of Forests (Administration) by shifting the post from the Office of the Chief Conservator of Forests, Northern Circle, Kannur to the Office of the Additional Principal Chief Conservator of Forests (Administration), subject to ratification from the Government.
