**ORDER**

Based on the recommendation of the Civil Service Board meeting held on 21.03.2017, the following changes, transfer and postings of IFS officers are ordered with immediate effect.

i) The post of Additional Principal Chief Conservator of Forests (Forest Land & Resources) is re-designated as Principal Chief Conservator of Forests (Forest Land & Resources) and Shri. P.K.Kesavan IFS, Principal Chief Conservator of Forest (Working Plan & Research) and Custodian, EFL is posted against the re-designated post. He will also look after the functioning of Special Afforestation & Nodal Officer, CAMPA and function as Custodian, EFL.

iii) Shri. Anirudh Kumar Dharni IFS (KL:1987) who is waiting for posting on repatriation from Central Deputation is posted as Additional Principal Chief Conservator of Forest (Vigilance & Forest Intelligence).
