As per the Government letter No. D3-47886/2015, dated: 03-03-2016 select list of Junior Superintendents for appointment as Senior Superintendents in Kerala Forest Department for the year 2016 was prepared by the Departmental Promotion Committee (Lower) in the meeting held on 01-02-2016 and was approved by Government as per letter No. 39/F2/2016/F&WLD, dated: 03-03-2016. The same has been published in the Kerala Gazette vide No. 614, dated: 08-03-2016. At present there are 01 (one) post of Senior Superintendents lying vacant in the office of the Chief Conservator of Forests (Eastern Circle), Palakkad consequent to promotion of Shri. Sasidharan.K, Senior Superintendent to Administrative Assistant and the promotion proposal has also submitted to Government.

As per government letter cited above, the Junior Superintendents up to serial No. 17 has been promoted as Senior Superintendents. In the select list Shri.Paulose K.A, serial No. 18 is the next eligible senior most Junior Superintendent to be appointed by transfer as Senior Superintendent.

Thus, considering the administrative convenience Shri. Paulose K.A, Junior Superintendent, office of the Divisional Forest Officer, Kothamangalam is promoted to the post of Senior Superintendent and posted as such in the office of the Chief Conservator of Forests, Eastern Circle, Palakkad.

The Divisional Forest Officer, Kothamangalam will relieve Shri. Paulose K.A within five days as instructed in Circular No. 05/2013, dated: 11-06-2013 of the Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Kerala after making necessary internal arrangements and report.
