**ORDER No. E4-4341/2010 DATED 23.11.2018**

As per the provisional seniority list of Section Forest Officers published 1<sup>st</sup> cited above up to Serial No.786 have been promoted to the category of Deputy Range Forest Officers. As per order 3<sup>rd</sup> cited, Sri.M.Kesavan, Seniority No.716, was exempted from promotion due to non-declaration of probation in the cadre of Section Forest Officer. Vide reference 4<sup>th</sup> cited, Chief Conservator of Forests (N/c), Kannur has reported that his probation was declared with effect from 09.05.2015. His service particulars are verified and found to be eligible for promotion as Deputy Range Forest Officer.
