**ORDER NO. D3-194/2013 Dated: 18.01.2018**

As per Orders read as 1<sup>st</sup> and 2<sup>nd</sup> above, 25% of the posts of Senior Superintendents are eligible for ratio promotion as Senior Superintendent (Higher Grade).
