As per the proceedings order dated: 30-10-2014, cited 1st above, the post of Senior Superintendent in the office of the Additional Principal Chief Conservator of Forests (Development) attached to Forest headquarters is temporarily shifted to Treasury section ('T'- section) and the post of Junior Superintendent in 'T'-section is shifted to the Office of the Additional Principal Chief Conservator of Forests (Development) due to the reasons of introduction of treasury bill system from 01-04-2014 in Kerala Forest Department vide references 2nd and 3rd cited above and in order to get the continuous service of Smt. C.Vimala, Junior Superintendent in 'T'-section in the office of the Additional Principal Chief Conservator of Forests (Administration). Smt. C.Vimala, Junior Superintendent has been promoted as Senior Superintendant and posted in the 'T'-section in the office of the Additional Principal Chief Conservator of Forests (Administration). As and when Smt. C.Vimala, Senior Superintendent is promoted as Administrative Assistant, the post of Senior Superintendent is transferred to the 'D' section in the Office of the Additional Principal Chief Conservator of Forests (Administration). In addition to the above, the convening of selection Committee Meeting for the preparation of select list of State Forest Officers of the state also vests with 'D' Section, the following orders are issued.

Under the circumstances mentioned above and due to administrative exigencies, the post of Senior Superintendent from Treasury (T) section in the office of the Additional Principal Chief Conservator of Forests (Administration) is shifted to the 'D' Section in the office of the Additional Principal Chief Conservator of Forests (Administration) and the post of Junior Superintendent of 'D'-Section is shifted to 'T'-section in the office of the Additional Principal Chief Conservator of Forests (Administration) as and when Smt. Vimala. C, Senior Superintendent of 'T'-section is promoted as Administrative Assistant.
