**PROVIDENT FUND- GENERAL PROVIDENT FUND (KERALA) RULES-  
FURNISHING OF THE OPTION STATEMENTS TO THE ACCOUNTANT  
GENERAL- LAST DATE- FIXED**

**In Notification No. 39645/CR/62/Fin. dated 1-4-1964 appended to G.O.(P) No. 140/64/Fin (PF) dated 1-4-1964, a period of three months from the 1<sup>st</sup> April, 1964 was fixed as the period within which the subscribers to the State Provident Fund (Travancore), the General Provident Fund (Cochin) and the General Provident Fund (Madras) might communicate the option referred to in rule 5 of the General Provident Fund (Kerala) Rules, to the Account Officer. The period of three months referred to above expires on the 30<sup>th</sup> June, 1964. The Accountant General has requested that necessary instructions may be issued to the Departmental Officers to see that the options in respect of the Gazetted Officers reach his office on or before the 30<sup>th</sup> June, 1964 and the consolidated option statements in respect of the non-Gazetted Officers not later than the 15<sup>th</sup> July, 1964.**

**2. Since the existing subscribers to the State Provident fund (Travancore), General Provident Fund (Cochin) and General Provident Fund (Madras) can exercise their option even on 30<sup>th</sup> June, 1964, it may not be correct to prescribe 30<sup>th</sup> June as the last date for receipt of such options in the Office of the Accountant General. Government, therefore, direct that the options in respect of Gazetted Officers should reach the Office of the Accountant General on 10<sup>th</sup> July, 1964 at the latest. All Heads of Departments and Offices are, therefore, requested to see that the Gazetted Officers working in their Offices have actually forwarded their options to the Accountant General. The Heads of Departments and Offices should also forward to the Accountant General the consolidated statements of options exercised by the non-Gazetted Officers working in their offices. Such statements should reach the Audit Office on or before the 15<sup>th</sup> July, 1964. In the consolidated statement, the date on which each subscriber has given his option and the Provident Fund Account Number already allotted to him by the Accountant General should be indicated.**
