Public Service – Persons appointed on provisional basis – Grant of increments – Further orders issued.

O R D E R

According to the orders issued in G.O. read as first paper, persons appointed to posts under the State Government whether by direct recruitment, by transfer or by promotion, irrespective of whether the appointments were made in consultation with the Kerala Public Service Commission or not, where such consultation was necessary, would be allowed to draw their increment in the posts to which they were appointed, although the appointments were treated as provisional or having been made under the emergency provisions. In the GO second read above it was clarified that as long as the orders issued in G.O. read as first paper continued to be in force, increments shall be allowed to persons holding appointments under the emergency provisions, irrespective of the whether or not they possessed the prescribed qualifications and their services were likely to be regularizes, provided they were otherwise eligible to draw such increments.

2) In the G.O read as third paper, Government clarified that the above concession was granted in view of the difficulties being experienced by the provisional hands for no faults of theirs and that the concession would be available only for a period of two years from 9-7-1980

3) In the G.O. read as fourth paper, Government ordered that then implementation of the Government order dated 9-7-1980 be kept in obeisance till 9-7-1984 and that immediate action be taken by the Heads of Departments to regularize the provisional appointments/promotions within the above period, by finalizing the special rules or the seniority lists, holding the meetings of the Departmental promotion committees, as the case may be. It was also clarified therein that the above time limit would not be extended further and the Heads of Departments would be personally held responsible for the delay in regularization of the provisional appointment/promotions in their departments.

4) Government are receiving requests form different quarters to extend the time limit ordered in G.O. fourth paper above.

Government have examined the matter and are pleased to order that that implementation of the Government order dated 9-7-1980 be kept in obedience up to 31-12-1985. Heads of Departments will expedite finalization of Special Rules, Seniority list and preparation of select lists where special rules have already been finalized. The above time limit will not be extended further.
