PAY REVISIONS 1973 AND 1978- INDIVIDUAL REQUESTS FOR
RE-OPTION NOT COVERED BY THE GUIDELINES – CHANCE
FOR RE OPTION – ORDERS ISSUED.

ORDER

In Government Order read as third paper above, Government granted another chance to all Government employees for the exercise of re-options in respect of 1973 and 1978 Pay Revisions in cases which do not squarely fall within the purview of the guidelines contained in the Government Order read as first paper above. The time granted for such re-options expired on 31-12-1984.

2. The intention of Government was not to restrict the facility for re-option to Government employees but to make it available to staff of aided Schools, Private Colleges Polytechnics also. However it has been brought to the notice of Government that the Government Order dated 15-9-1984. was interpreted in the sense that it applied only to Government employees and accordingly certain Controlling officers in respect of teaching and non teaching staff of Aided Schools, Private Colleges /Polytechnics did not permit such employees to exercise re-option in accordance with the above Government order. In the circumstances Government are pleased to give another chance to teaching and non- teaching staff of Aided Schools, Private Colleges and Private Polytechnics for exercising re-options in respect of 1973 and 1978 Pay Revisions, in case which do not fall within the purview of the guidelines contained in the Government Ordered as first paper above subject to the conditions specify in the Government Order read as third paper above viz.

(i) arrears on account of such revision of option will be payable only from the date of exercise of re-option

(ii) refund of excess pay drawn if any will be made in lump.

3.The teaching staff of both Governmental Aided Schools are eligible to exercise option for higher grades with effect from the dates beneficial to them provided the service requirements satisfied in their cases for such higher grades. So also under the 13 years higher grade” scheme employees are permitted to elect any date for the higher grade. So also under the required qualifying services. The change of pay and the date of increment consequent on the re-options for the 1973 and 1978 pay Revisions may necessitate re-option for the higher grades . So Government are also pleased to grant another chance to Government employees and staff of aided Schools,

Private Colleges, and Polytechnics to exercise re options for postponement of higher grades which are consequential to the re-options made as per the Government Order dated 15-9-1984 and also re-options to be made as per orders contained in para 2 above. Such re-options will also be subject to the conditions specified in para 2 above.

4. The Orders issued in the Government Order cited as second paper above regarding the adjustment of arrears in respect of refund will be operative in all the cases.

5. The last date for exercise of revised option as per these orders will be 30-4-1985. Request for re-option received after this date will not be entertained on any account.

6. The Non Gazetted Officers will forward their options to the Officer who draws their salary or countersigns the salary bills as the case may be and the Gazetted Officers to the Accountant General, Kerala. The option statement will be pasted in the Service Book in the case of Non Gazetted Officers after being countersigned by the concerned Officer with date.

7. The Heads of Department will ensure that the contents of this order are brought to the notice of all the employees under their control, including those on deputation to foreign service
