ORDER

Consequent on the issue of pay revision orders 1988 a number of requests are being received seeking permission for exercising re-option for postponement of service based higher grade/non -cadre promotions sanctioned during the period from 1-7-1988 (date of effect of pay revision 1988) to 1-11-1989 (date of issue of pay revision orders.)

2. According to Rule 12 of the rules for fixation of pay in Annexure III to the Government Order read above, promotion or appointments made on or after 1st July 1988 shall be deemed to have been made to the revised scale of the post and pay in such cases fixed under the normal rules.

3. Government have examined the issue in detail and are pleased to allow another chance of re-option for postponement of service based higher grade/non-cadre promotions to those officers who get such promotions during the period from 1-7-1988 and 1-11-1989 subject to the following conditions :

- (i). The excess pay drawn should be refunded in lump.
- (ii). Monetary benefits arising out of the fixation of pay in the revised scale consequent on re-option for periods upto 30-11-1989 will be credited to Provident Fund Accounts, etc., as ordered in G.O. (P) No.114/90/(10)/Fin. dated 15-2-1990 and for periods thereafter will be allowed in cash.
- (iii). Revised option should be exercised within three months from the date of this Order.
