ORDER

As per the existing rules leave without allowances taken otherwise than an medical certificate will not count for increment. Representations have been received by Government to count the period spent for acquitting higher qualifications which are primarily of advantage to the Government, for granting increments. Government after examining the question in all its aspects consider that it is only just that the periods of leave without allowances taken by Government servants for acquiring post-graduates qualification which are primarily of advantage to the Government, for granting increments. Government after examining the question in all its aspects consider that it is only just that the periods of leave without allowances taken by Government servants for acquiring post-graduate qualifications in the field of their duties and which are primarily of benefit to the State, are counted for increments. Government are therefore pleased to issue the following notification.

NOTIFICATION

S.R.O.No. 801/76.----In exercise of the powers conferred by Sub section (1) of section 2 of the Kerala Public Services Act 1968 (19 of 1968) read with section 3 thereof the Government of Kerala hereby make the following amendments to the Kerala Service Rules namely:-

AMENDMENTS

C.S.No. 295/76

In Part I of the said rules,

(1) In rule 33, in sub-clause(2) of clause (b),---

(a) In the proviso---

(i) For the words "Provided that", the words "provided further that" shall be submitted:

(ii) for the words, brackets and figures "clause (1) or (2)", the words, brackets and figures "sub-clause (1) or (2)" shall be submitted;

(b) before the proviso, the following proviso shall be inserted, namely:-

"Provided that leave, without allowances granted under rule 91A shall count for increments subject to the following conditions:-

(1) the period qualifying for increments shall be restricted to the normal period required for completion of the course, and

(2) Increments shall be granted only on production of the Diploma or Degree on completion of the course".

(3) in the Note, for the word, brackets and figure "clause(2)", the word, brackets and figures 'sub-clause(2)' shall be substituted;

(4) in rule 91, the portion beginning with the words "Officiating or temporary technical officers" and ending with "a penalty of Rs.1000" and Note (1) there under shall be omitted;

(5) after rule 91, the following rule shall be inserted, namely:-

"91A. Officers with a continuous officiating or temporary service of five years or more may be granted in addition to any leave to which they are eligible for, leave for undergoing post graduate courses in the sphere of their duties which are primarily of benefit to the State, such as post-graduate courses for Teachers, Engineers and Doctors. The leave shall be granted only with due regard to the usefulness of the higher studies to the public service."
