**ORDER**

In the Government order read as first paper above , Government have issued orders enhancing the retirement benefits of state Government the retirement benefits of state Government employees and allowing percentage increase in pension at varying rates to those retired during different periods prior 1-7-1978. It has also been specified that , the percentage increase will be allowed after merging all adhoc / temporary increase s sanctioned . In the g.o read as second paper above , it has been ordered among other things , that the enhanced pension fixed after merging temporary increases sanctioned . In the G.o read as second paper above , it has ordered , among other things that the enhanced pension fixed after merging temporarily / increases and allowing percentage increase will be allowed after Merging temporarily adhoc increase , and allowing percentage increase in pension , will be reckoned as basis pension for the purpose of commutation . IN THE Government Order read as the third above it has been clarified that in respect of those who were drawing minimum pension above , will be allowed the minimum pension .

2. The Accountant General , in his letter read as fourth paper above , has sought clarification whether the element of minimum pension increase (i.e. the amount added to make up the minimum pension ) in the case of those drawing minimum pension is commutable in terms of the G.o read as second paper above .

3. Government has examined the case in detail. The element of minimum pension increase has been allowed the same treatment , as in the case of ado / temporary increase in pension , in the matter in the matter of calculating the percentage increase in pension as per the G.O read as third paper above . It is therefore clarified that in respect of those who were drawing minimum pension as on 1—7-1978 and who were allowed percentage increase on minimum pension the

enhanced pension will be reckoned as basis pension for the purpose of commutation in terms of the G.O read as second paper above .
