ORDER

In the G.O. read as first paper above Government have accepted the decision of Government of India that the liability to pay the leave salary and allowances of an employee of the State Government who surrenders earned leave while on deputation to Government of India will be that of the State Government. This has effect from 4-6-1971. In the letter read as second paper it was clarified that the liability of the State Government to pay the leave salary and allowance is limited to the extent the officer would have drawn in the State Service and the deputation allowance, Island Compensatory allowance and the like need not be paid during surrender of earned leave. Considering the hardship to the persons who have drawn leave salary during the period from 4-6-1971 to 4-10-1976 by way of refunding the excess leave salary drawn as deputation allowance, compensatory allowance etc. Government decided that the clarification need not be given retrospective effect and this decision was communicated to Accountant General in Government letter read as third paper. In the letter read as fourth paper the Accountant General has suggested that the clarification issued in the letter read as third paper may be issued in the form of a Government order as otherwise the clarification would take effect from the date of the original Government order. After considering the various aspects of the case, Government are now pleased to order that the clarification issued in the letter read as second paper that the liability of the State Government to pay leave salary and allowances for surrender of leave is only to the

extent the Officer would have drawn the leave salary and allowances in the State Service and the Deputation Allowance, Island compensatory allowance and the like need not be paid during surrender of earned leave by the deputationists to Government of India will take effect only from 4-10-1976 i.e., the date of issue of the letter read as second paper.
