**ORDER**

In the G.O. read as first paper above, Government have introduced a Family Benefit Scheme for the Government employees with effect from 1-9-1977. In the G.O read as third paper above it was ordered that the employees who were in service on 1-9-1977 and who join the scheme would have to pay arrears of subscription from 1-9-1977 to the date of their joining the scheme. The period of option has been extended from time to time and present extension ordered in the G.O 4<sup>th</sup> cited will expire on 18-6-1978.

There have been representations that payment of arrears may not be insisted upon in the case of employees who have taken time to join the scheme. Government have examined this question and are pleased to order that employees who file their option statements for the Family Benefit Scheme on or after 1-5-1978 need not pay arrears to subscription. The subscriptions from such employees need be collected only with effect from the month in which the employees opt for the scheme. In the case of other arrears of subscription will be collected as already ordered. All the drawing and self-drawing officers will effect the deductions towards the scheme accordingly.
