ORDER

In the G.O. read as first paper above, orders were issued for the absorption Of all full-time contingent employees of the Government Departments who were continuously in service from a period prior to 1-4-1965 into regular pensionable establishment with effect from 1-4-1968. It was also ordered that no full-time posts borne on contingencies would be created after 1-4-1968. But appointments of provisional hands were made even after 1-4-1968 against the full-time contingent posts which were brought into regular establishment. In the G.O read as second paper, Government had ordered that no full-time posts of contingent employees will be filled in by Employment Exchange hands in future. The provisional appointments made between 1-4-1968 to 31-03-1971 were regularized later. Vide the G.O. cited third.

G.O. read as 4th paper above says only that those contingent employees who were appointed during the period from 1-4-1965 to 31-3-1968 and who are still continuing in service (last grade), are eligible to continue in service up to 60 years of age. But the above orders are silent regarding the contingent employees appointed on or after 1-4-1968 but before 7-4-1970.

Government have examined the matter in detail and are pleased to order the those full-time contingent employees who were appointed as provisional employees during the period from 1-4-1968 to 7-4-1970 and who are still continuing in service shall be treated as having been absorbed into regular establishment with from 7-4-1970 subject to exercise of reoption by them. Government also reiterate that the cases of those who are in service will alone be considered for giving the benefits contemplated in this G.O and order that no benefits other than those admissible under Rule 60 (b) of Kerala Service Rules, Part I shall be allowed to them.
