**ORDER**

In the G.O. read as first paper above, Government have issued orders allowing the benefit of higher grade with effect from 1-7-1979 to all Non Gazetted Officers who remain in the entry grade without any promotion in the normal course, on completion of 13 years service in that grade. Detailed instructions for the implementation of the above orders have been issued in the G.O. second cited. In the G.O. 3<sup>rd</sup> cited Government also ordered that the employees borne on completion of 13 years service in that grade, irrespective of whether the grade is entry grade or not. In the G.O. read as 4<sup>th</sup> paper above, the benefit ordered in the G.O. 3<sup>rd</sup> cited, has been extended to all Non –Gazetted Officers including those in the scale of pay Rs.6001 100. Now certain heads of departments have sought clarification whether higher grade on completion of 13 years can be sanctioned to those who have relinquished promotion.

2. The Government have examined the question in detail and are pleased to order that in case involving relinquishment of promotion, higher grade based on 13 years service in the entry grade/ same grade will be granted subject to the terms and conditions stipulated in the Government orders read above, after excluding the periods if any, the incumbents concerned actually worked in the higher post on promotion which they relinquished .

3. These orders will have effect from 1-7-1979.
