ORDER

The Forest Schedule Rates for elephant dragging of timber was revised previously as per the Government Order read as 1<sup>st</sup> paper above. The Additional Principal Chief Conservator of Forests (Development) as per letter read above has informed that there is an urgent necessity for revising the Forest Schedule Rate for dragging timber by using hired elephants since the hire charges of elephants have gone up considerably during last few years, timber operations have become difficult which in turn negatively affects revenue to the exchequer.

Government have examined the proposal in detail and are pleased to accord sanction for enhancing the rate for dragging timber using hired elephants (FSR item 139) as shown in table given below:
