ORDER

An ex-cadre post of Additional Principal Chief Conservator of Forests (Planning) is created in the Scale of Pay of Rs.67000-79000 by keeping in abeyance the cadre post of Chief Conservator of Forests (Planning).

2. The post of Additional Principal Chief Conservator of Forests (Planning) is declared equivalent in status and responsibility to the cadre post of Additional Principal Chief Conservator of Forests (D&P), Thiruvananthapuram under Rule 11 of IFS (Pay) Rules.

3. Shri. P.K.Kesavan IFS(KL:1986) on repatriation from Central Deputation is posted as Additional Principal Chief Conservator of Forests (planning) in the ex-cadre post created vide para 1 above.

4. Shri.K.G.Mohanlal IFS, (KL:1983) who is on state deputation as Chairman & Managing Director, Kerala State Road Transport Corporation is repatriated to the parent cadre, and on repatriation from state deputation Shri.K.G.Mohanlal IFS is posted as Additional Principal Chief Conservator of Forests (IHRD) in the existing vacancy.




