ORDER

As per the notification read as 1st paper above, Government of India has revised the cadre strength of IFS Kerala Cadre and the existing cadre posts were also redesignated. The re-designated cadre posts are equated to the existing post in Indian Forest Service of Kerala Cadre as follows. The duties and functions of the post prior to cadre review is assigned to the new cadre post.


