ORDER

Sri. C.C Joseph Lower Division Clerk (now Forester) Munnar Divisional granted leave on Medical grounds for the period from 18-9-1979 to 25-9-1974 as detailed below.

1. Earned leave for 11 days from 18-9-1973 to 28-9-1973
2. Half pay leave for 20 days from 29-9-73 to 18-10-1973
3. Leave without allowance for 342 days from 19-10-1973 to 25-9-1974.
