ORDER

Government have approved the Memorandum of Association and Rules and Regulations of State Forest Development Agency (SFDA) Kerala, which is constituted as an apex body to the Forest Development Agencies (FDAs) in the State as per the reference read 1st paper above. As per the Rules and Regulations in force the Principal Chief Conservator of Forests and Head of Forest Force is the Chairman and the Chief Conservator of Forests (E&TW) is the Member Secretary of SFDA.

The Principal Chief Conservator of Forests (Dev & PFM) in his letter read 2nd paper above has pointed out that since the post of the Chief Conservator of Forests (E&TW) was upgraded to Additional Principal Chief Conservator of Forests, there is no Chief Conservator of Forests (E&TW) post at present. So also the post of Principal Chief Conservator of Forests (Dev & PFM) was created as ex-cadre as a supervisory authority of NAP, SFDA, EDC and allied programmes.

In the aforesaid circumstances the Principal Chief Conservator of Forests (Dev & PFM) has requested to issue orders delegating the Principal Chief Conservator of Forests (Dev & PFM) the supervisory authority of E&TW wing as the Chairman of SFDA, Kerala and that of the Additional Principal Chief Conservator of Forests (E&TW) as its Member Secretary.

Government have examined the matter in detail and are pleased to reconstitute the existing organizational set up the State Forest Development Agency (SFDA) Kerala, by delegating the Principal Chief Conservator of Forests (Dev & PFM) as Chairman and Additional Principal Chief Conservator of Forests (E&TW) as Member Secretary of SFDA.
