3. Minutes of the 1<sup>st</sup> Committee Meeting held on 26.03.2013 on speedy disposal of seized/confiscated vehicles, chaired by Chief Secretary.

## ORDER

In the Government Order read (1) above procedure was laid down for fixation of fair value of vehicles taken charge of/confiscated/seized by the Police.

2. As per Government Order read (2) above, the procedure for fixation of fair value of vehicles taken charge of/confiscated/sized by the police as stipulated in Government Order (1) above was made applicable to Transport Department, Excise Department and Forest Department.

3. The first meeting of the committee read as (3) above recommended to revise the guidelines for fixing the fair value of vehicles seized/confiscated.

4. Government, having examined the above recommendation, are pleased to order that while fixing the fair value of vehicles seized/confiscated, the depreciation pattern will be 20% of the purchase value for the first year and thereafter up to 5<sup>th</sup> year it will depreciate at the rate of 20% of the depreciated value every year. From the 6<sup>th</sup> year up to 10<sup>th</sup> year the depreciation will be 10% of the depreciated value every year. After 10 years it will be treated as scrap and clause 2(c) in Government Order read (2) above regarding scrap shall apply for disposal of the same.

5. This Government Order will supercede the orders issued vide Government Order read (1) above.


