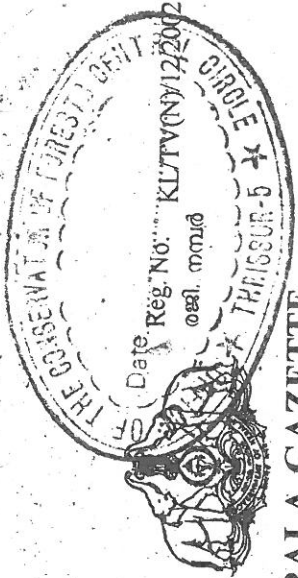

NOTIFICATION

S. R. O. No. 269/2002.—In exercise of the powers conferred by sub section (1) of Section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with Section 3 thereof, the Government of Kerala, hereby make the following rules, further to amend the Kerala Service Rules, namely:—

RULES
(C. S. No. 12/2002)

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Amendment) Rules, 2002.
2. *Amendment of the rules.*—In Part I of the Kerala Service Rules, in the first proviso to Rule 28A
 - (a) for the letters and figures "Rs. 2640" the letters and figures "Rs. 3900" shall be substituted.
 This amendment shall be deemed to have come into force on the First day of March, 1992.
 - (b) For the letters and figures "Rs. 3900" as amended by sub-rule (a) above, the letters and figures "Rs. 12,600" shall be substituted.
 This amendment shall be deemed to have come into force on the First day of March, 1997.

Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

In G. O. (P) No. 600/93/Fin. dated 25-9-1993 and in G. O. (P) No. 3000/98/Fin. dated 25-11-1998, the monetary limit prescribed in Rule 28A has been enhanced with effect from 1-3-1992, and 1-3-1997 respectively. This amendment is intended to give statutory validity to the above orders.
