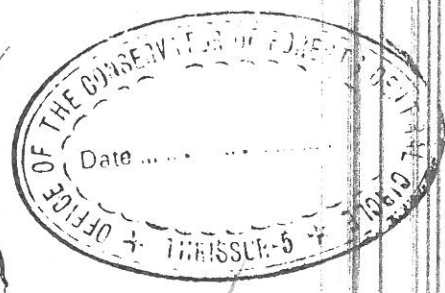

ORDER

As per the G. O. read as first paper above, an employee availing leave without allowance for taking up employment abroad or elsewhere should join duty at least one year before his date of superannuation. In the G. O. read as second paper above it was further ordered that in case he/she fails to rejoin duty within the said period his/her service shall be terminated.

However, as per the G. O. read as third above Government have cancelled the G. O. dated 1-6-1998, as such a condition would adversely affect the interests of those who were already on leave and are on contractual agreement in foreign job. But the order dated 8-8-1997 is still in force.

Accountant General as per his letter cited has sought for some clarifications on the G. O. dated 8-8-1997. Accordingly, Government have examined the matter in detail and are pleased to order that in the case of those employees who are already on leave as on date of issuance of G. O. dated 8-8-1997, they can rejoin duty on the expiry of the sanctioned leave in full or one year before attaining superannuation age if they desire so. However in future cases, all persons who take Leave Without Allowances to take up employment abroad or elsewhere

including extension of leave already availed have to rejoin 12 months before the date of superannuation and all the leave Sanctioning Authorities should specify in the order sanctioning the Leave Without Allowance that the employee should rejoin duty one year before his date of superannuation.

Formal amendments to Rules in part III, KSRs to this effect will be issued separately.
