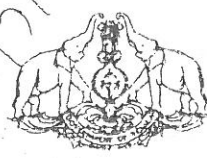

ORDER

As per the Government Order read above, Government ordered certain economy measures to overcome the existing financial crisis. It was ordered among other things that new recruits in Government service and PSUs/Autonomous Institutions/Statutory Undertakings would be given only basic pay for first two years of service.

Many departments have sought clarification to Government as to whether full salary can be given to those who are already in service and got new appointment subsequently after 15-1-2002. Some Departments raised another doubt to whether the date of advice by the Public Service Commission or date of appointment order issued by the appointing authority will be the criteria for deciding new recruits in Government service.

Government have examined the matter in detail and are pleased to order that those who are already in service and got new appointments after 15-1-2002 are eligible for full pay and allowances irrespective of the date of joining of their duty in the new posts. As regards fresh appointments, those who were advised by KPSC up to and including 15-1-2002 shall be granted full salary.
