SMALL SCALE UNITS WITHIN THE STATE OF KERALA—RESTORATION OF CONCESSIONS TO SSI UNITS—SANCTIONED—ORDERS ISSUED

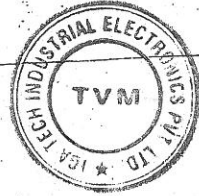
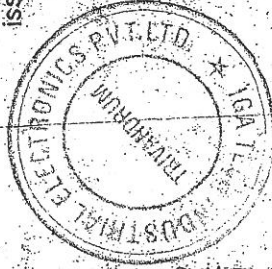
ORDER

As per the Government Order read above, the exemption allowed to the SSI units from remittance of EMD/Bid Security and Security Deposit was withdrawn and the 75% price preference admissible to the SSI units was reduced to 5%. The Industries Department has forwarded a proposal for restoration of the benefit of 15% price preference to the SSI Units within the State, and to exempt these units from remittance of EMD, Bid Security and Security Deposit.

Government have examined the matter in detail and are pleased to issue the following orders:

(a) All the Small Scale Industrial Units that are registered with the Stores Purchase Department of Kerala and working within the State of Kerala will be exempted from payment of EMD, Bid Security and Security Deposit (Performance Guarantee).

(b) Price preference of 5% that is admissible to the Small Scale Industries as per the G.O. read above will be enhanced to 10% and will continue till 31-3-2012.



(c) The PSUs that are working on competitive basis need no allow the above concessions to the SSI units. These concessions be allowed only by the State Government Departments, LSGIs, Development Authorities, Kerala Khadi & Village Industries Board, Kinfra, Kerala State Road Transport Corporation, Kerala State Electricity Board (KSEB) and Kerala Water Authority.

(d) The additional expenditure on account of the above concessions allowed by KSEB will be compensated from the plan allocation to the Industries Department.

(e) The price preference of 5% that was admissible to the medium and large scale industries in the private sector within the State of Kerala over the products of Central/State PSUs will be extended for a further period upto 31-3-2012.

Necessary amendments to the Stores Purchase Manual will be issued separately by the Stores Purchase Department.

These orders will take immediate effect.
