Karinilam, Mundakkayam, Kottayam as members to the State Board for Wildlife reconstituted as per notification issued under G. O. (P) No. 113/2012/F&WLD dated 28th November, 2012 and published as S.R.O. No. 820/2012 in the Kerala Gazette Extraordinary No. 1307 dated 28th November, 2012 and make the following consequential amendment to the said notification, namely:—

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government of Kerala have reconstituted the State Board for Wildlife as per notification issued under G.O. (P) No.113/2012/F&WLD dated 28th November, 2012 and published as S.R.O. No. 820/2012 in the Kerala Gazette Extraordinary No. 1307 dated 28th November, 2012. Two members representing Non-Governmental Organizations under clause (d) and one member from amongst eminent conservationists, ecologists and environmentalists, under clause (e) of sub-section (1) of section 6 of the Wildlife Protection Act, 1972 were left unfilled at the time of reconstitution of the Board. Government have now decided to nominate three persons as members in the existing vacancies of the Board.

The notification is intended to achieve the above object.
