

Forest & Wildlife Department- Working down of Timber and Firewood from Akamala and Paruthipra Teak Plantations in Wadakkanchery Range of Thrissur Division-Tenders approved-Orders Issued.

ORDER

Tenders for working down Timber and Firewood from 1938 Akamala, 1940 Paruthipra and 1941 Akamala Teak Plantations in Wadakkanchery Range, Thrissur Division, were called for by the Divisional Forest Officer, Thrissur and 4 tenders each were received for the above works. The rate quoted by Shri.I.K.Sulfikar, Illickal House, Peruvampadam (P.O.), Edavanna, Nilambur is the lowest for all the three works. On negotiation, the lowest tenderer has expressed his willingness to take up the work at 91% above the basic rate for the 1938 Akamala and 1940 Paruthipra Plantations and 102% above the basic rate for 1941 Akamala Plantation. The Chief Conservator of Forests (Northern Region) as per the letter read as second above, has recommended to approve the tenders received from Shri.Sulfikar for the above works.

(2) The Tender Committee for the Department of Forest that met on 26.04.2002 considered the proposal and found that eventhough the rates quoted are substantially above the basic rates, there is no scope for further negotiations for bringing down the rates and that there is no scope for taking up the works departmentally. The Committee therefore recommended Government to approve the tenders received from Shri.I.K.Sulfikar, Illickal House, Peruvampadam, Edavanna, Nilambur at 91% above the basic rate for 1938 Akamala, 1940 Paruthipra Teak Plantations and 102% above the basic rate for 1941 Akamala Teak Plantation.
