P C C TIMBERS 59/6991, Mooriyad, Chalappuram (PO), Kozhikode-673002 submitted an application vide reference 1st cited for renewal of Property Mark "PCC" in favour of the said firm, in Kozhikode Timber Sales Division for trading 6,000 M<sup>3</sup> Timber (Including Teak & Rose wood), Teak Poles 10,000 Nos, 200 MT Billets. The Depot yard of the firm is in Resurvey No: 183/7 (8.0938-ARS) in Panniyankara Village, in Kozhikode Taluk. The firm has produced 25 impressions of the proposed Property Mark "PCC" Possession Certificate of proposed Timber Depot Yard issued by the Panniyankara Village Officer, Sketch of land and Tax paid receipt of the proposed Timber Depot Yard and Copy of GST certificate issued by Goods and Services Tax department with GST Registration Number 32AAHFP2948P1ZR.

As per Location Sketch No. 555/2026 dated 13.03.2026 of Panniyankara Village Officer. the land Resurvey No: 183/7 (8.0938-ARS) in Panniyankara Village, in Kozhikode Taluk. is under possession of Sasilatha. P.C, W/O P.C. Chandran, Surya, Pilakkadan, Chettyamtammal, V.K.K Menon Road, Kallai (PO), Kozhikode, 673003 and necessary consent agreement attached.

Correctness of details in application, details of the timber yard, genuineness and ownership antecedents of the applicant etc have been got verified through the Deputy Range Forest Officer (Grade) & Estate Officer, Vanasree, Mathottam. Deputy Range Forest Officer (Grade) has submitted his verification report vide reference 2<sup>nd</sup> cited. Details furnished in the application, possession and ownership of the proposed timber yard, genuineness and are found to be correct as per the reports of the Deputy Range Forest Officer (Grade). Antecedents of the applicant are found to be satisfactory as per report of the Deputy Range Forest Officer (Grade), vide reference 2<sup>nd</sup> cited. 1. Trading of timber should be as per the Kerala Forest Act, 1961, the Kerala Forest Produce Transit Rules, 1975, the Kerala Essential Articles (Control) Act, 1986, the Kerala Promotion of Tree Growth in Non-Forest Areas Act, 2005 and related Act and rules.
2. Form No: IV Passes shall be issued to the Property Mark Registration Certificate holder on application on realization of prescribed fees by the Divisional Forest officer, Timber sales Division, Kozhikode, after causing necessary enquiries and verification, for transport of forest produces, except for essential articles under the Kerala Essential Articles (Control) Act, 1986 as specified in GO (MS) No 30/92 dated 23/07/92 and SRO No: 243/93 which was published in Kerala Gazette No.6 dated 09.12.1993 and its subsequent amendments.
3. Those species of timber which are exempted from transport passes in Kerala, but not exempted and required transport passes in other states should not be transported to other states under the cover of the form IV passes issued to the Property Mark Certificate holder/ the firm and in such cases passes prescribed as per sub rule 4(b) should be obtained for export of such produces.
4. All timber in transit, covered by the form IV passes issued by the Property Mark certificate holder should be stamped at both ends with the Property Mark registered with the Divisional Forest Officer.
5. Property Mark Registration Certificate holder shall issue Form No: IV Passes strictly in the serial order.
6. Property Mark Registration Certificate holder should keep Timber Stock Register in which date wise details of opening stock of timber, receipt, disposal, balance stock of timber etc should be clearly recorded. Species wise details of the timber (both number of logs and its volume) should be shown clearly. Details of the source/authority etc should be shown against its receipt and disposal details should indicate the Number and date of pass issued, corresponding sale bill number, name and address of person to whom sold etc.
7. It shall be open to any Forest Officer not below the rank of a Section Forest Officer to inspect the timber yard or trading place of the Property Mark Registration Certificate holder or check the timber or the accounts at any time.
8. The Property Mark Registration holder or agents or workers or others engaged by him or his agents should not misuse the Property Mark or Property Mark Registration Certificate or Form IV Passes issued to them from the Forest Department.
9. The Property Mark Registration holder or agents or workers engaged by him or his agents should not involve in any Forest or Wildlife offences.
10. The Divisional Forest Officer may, for good and sufficient reasons to be recorded in writing, cancel or suspend the Property Mark Registration Certificate at any time.
11. The date of issuance of Form IV permits should be entered invariably in Numeric and in words.
12. While issuing the Form IV permit, under Col.2 (quantity), No of logs covered by the permit and its quantity in cum, and Name of species, length and girth of each log in metric system (in Meter and Centimeter) and its volume shall be recorded in all the copies of the passes.

13. All columns of each Form IV Pass should be filled and signed with date by the Property Mark Registration Certificate holder
14. The Form IV pass shall not be signed before all the columns there in are filled up.
15. The time allowed in the Form IV permits should be minimum required, but shall not exceed to a maximum period of one month from the date of issue of the permit.
16. While issuing Form IV permit, the vehicle Number and the time of loading of the produces shall be recorded in the space below.
17. The Property Mark Registration holder should forward duplicate of each Form IV permit to the Divisional Forest Officer, Timber Sales Division, Kozhikode as and when issued.
18. The Property Mark Registration certificate holder should submit monthly returns of receipt and disposal and balance stock of timber and as well as the form IV passes should be submitted to the Divisional Forest Officer, Timber Sales Division, Kozhikode before 10<sup>th</sup> of the succeeding month.
19. Other conditions, restrictions, directions, rules, orders etc issued or imposed or passed or formulated by the Kerala Forest Department or the State or Central Government or the honorable Courts of Law from time to time shall also be binding to the Property Mark Registration certificate holder/ firm.
20. The following particulars of timber stock also should be furnished while applying for Form IV permits.

The Property Mark Registration holder shall be personally responsible for any commission or omission, violation of any of the provision of the Act and Rules, irregularity or misuse of passes, or malpractice etc in dealing or trading timber or lapses in fulfilling the above said terms and conditions etc by himself or agents or men or workers engaged by him or his agents etc in respect to dealing or trading timber, use of the registered Property Mark, handling and issuance of Form IV passes issued to him etc
