To render any other ancillary services as assigned from time to time.

The other terms & conditions of engagement will be in according to NHAI Policy Guidelines for engagement of External Professionals and Young Professionals No. 1.3.1.12/2017 dated 21.06.2017, amended from time to time. The Policy Guidelines are attached.
