Invitation of Proposals (RFP) from Accredited Governmental Agencies having capability to execute works directly using their own in-house infrastructure facilities and manpower and or cost effective techniques as stated in Para-3.2 of GO (P) 67/2021/Fin dated. 28/04/2021 for execution of public works in Non PMC (Non Project Management Consultancy) mode having a valid and active registration [as per GO (P) No. 104/2022/Fin dated. 02/09/2022 (and its connected Government Orders) of Government of Kerala to submit their competitive offer on Centage Charges (in percentage) excluding applicable GST for the below mentioned works.

1. Notice Requesting Proposals (RFP)

1) For and on behalf of the Government of Kerala, the Director, State Forest Training Institute, Walayar, Kerala Forest & Wildlife Department invites sealed proposals from Accredited Governmental agencies who are having a valid and active registration [as per GO (P) No. 104/2022/Fin dated. 02/09/2022 (and its connected Government Orders) of Government of Kerala] and who are entitled to take up works (as defined in GO (P) 67/2021/Fin dated 28/04/2021) for the following works :

- a) Extension of interlock road at Trainers' and HA/JS Quarters
- b) Extension of interlock road at Director's Quarters
- c) Laying of interlock tiles on the way leading to Forest Dispensary
- d) Laying of interlock tiles on the path linking Ganga and Yamuna barracks at State Forest Training Institute, Walayar in Non PMC (Non Project Management Consultancy) mode.

Only Accredited Governmental Agencies of Govt. of Kerala approved as per GO (P) No. 104/2022/Fin dated. 02/09/2022 (and its connected Government Orders) can submit their proposals. The bidders who wish to participate can download the RFP Document from the Website www.forest.kerala.gov.in or directly collect it from the office of the undersigned during working hours. Each page of the proposal document should be duly signed by the Authorized Signatory of the bidder agency in token of acceptance of the terms & conditions of this RFP document. The Director, State Forest Training Institute, Walayar reserves the right to cancel the RFP as a whole or in part without assigning any reasons whatsoever.



2. Instruction to Bidders



3. Definitions

Unless the context otherwise requires, the following terms wherever used in this RFP have the following meanings:

- A. "**Applicable Law**" means the laws and any other instruments having the force of law in India as they may be issued and in force from time to time.
- B. "**Proposals**" means proposal submitted by respondents in response to the RFP issued by the Department.
- C. "**Contract**" means the Contract signed by the parties for the project along with the entire documentation specified in the RFP.
- D. "**Day**" means Calendar Day
- E. "**Department**" means authorized officer of Kerala Forest Department, Government of Kerala
- F. "**Services**" means the work to be performed by the Accredited Governmental Agency pursuant to the contract to be signed by the parties in pursuance of any specific assignment awarded to them by the Department.
- G. "**The Bidder**" Means the entity which participates in the RFP and submits its proposals.
- H. "**The Purchaser**" means authorized officer of Kerala Forest Department, Government of Kerala



4. Objectives of RFP

This RFP has been floated for selection among the qualified accredited agencies through a fair and transparent bidding process, as envisaged in Para 6.1 of GO (P) No 67/2021/Fin dated 28-04-2021 of Govt. of Kerala. The proposed works for laying interlock tiles at various locations at State Forest Training Institute, Walayar is for improving the infrastructure facilities of the Walayar State Forest Training institute.

5. Scope of Work

The Department intends to award the work mentioned in Para 1 above as turnkey projects (in Non PMC mode) which involve the complete aspects of the project as envisaged in Para 3.2 of GO (P) 67/2021/Fin dated. 18/04/2021 of Govt. of Kerala.

The bidders who are technically qualified to take up such "General Civil Construction Works" should quote competitive Non PMC/ Centage Charges on the PAC Amount since the selection of the Accredited Agency will be done based on this as envisaged in Para 6 of GO (P) 67/2021/Fin dated. 28/04/2021 of Govt. of Kerala. While quoting the Non PMC Charges, the relevant clauses in the above said GO may be adhered to. The Bidders may quote for all the works in the form given in Annexure.

6. Timeline for the Assignment

The work has to be completed within one month.

7. Eligibility

The applicant must be an Accredited Government agency for execution of public works in Non PMC (Non Project Management Consultancy) mode having a valid and active registration [as per GO (P) No. 104/2022/Fin dated. 02/09/2022 (and its connected Government Orders) of Government of Kerala] and who are entitled to take up General Civil Construction works as Non PMC as per GO (P) 67/2021/Fin dated. 28/04/2021 of Govt. of Kerala.



8. Performance Quality Criteria

The details of civil works of similar nature carried out during the last 3 years along with documentary evidences to substantiate your efficacy in executing the works.

9. Period of Validity of Proposals:

Proposals shall remain valid for 60 days from the date of opening prescribed by the Purchaser. A PROPOSAL FOR A SHORTER PERIOD VALIDITY SHALL BE REJECTED BY THE PURCHASER AS NON-RESPONSIVE BID. In exceptional circumstances, the Purchaser may request the Bidder's consent for an extension to the period of validity. The requests and the responses shall be made only in writing.

10. Format and Signing Proposal

The bidder shall submit one complete set of RFP. **Each page of the proposal document should be duly signed and official stamp affixed by the Bidder or the Authorized Signatory of the bidder agency in token of acceptance of the terms & conditions of this RFP document.** The proposals shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be authenticated by the person or persons signing the proposals.

11. Submission of Proposals

The proposals should reach the O/o. The Director, State Forest Training Institute, Walayar Dam P.O, Walayar, Palakkad-678624 before the closing time mentioned at Paragraph 2.1 above and the proposals received after this specified time will not be accepted.

12. Right to Accept any RFP and to Reject any or All Proposals:

The Director, State Forest Training Institute, Walayar reserves the right to accept or reject any proposals, and to annul the bidding process and reject all proposals, at any time without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

13. Clarification of Proposals :

To assist in the examination, evaluation and comparison of Proposals, the Department may, at its discretion, ask the bidder for clarification of their proposals. The request for the clarification and the response shall be in writing. **However, no clarifications post proposal opening at the initiative of the bidder shall be entertained.** The purchaser shall evaluate the proposals in detail as per the conditions of the RFP document.



14. Sealing and Submission:

Duly signed proposals along with documents mentioned in Para 17 below shall be enclosed in an envelope, sealed, and deliver to the address as below on or before the last date and time of submission

Proposals in unsealed covers and those proposals which are not complete in any aspect will be summarily rejected.

15. Selection and declaration of successful bidder

Selection will be made purely on the basis of the lowest quote for Non PMC/Centage Charges subject to the condition that the technical qualification of the applicant for taking up General Civil Works as mentioned in the GO (P) 67/2021/Fin dated. 28/04/2021 is satisfied and all other conditions of this RFP are met satisfactorily. The bidder has to quote the Non PMC / Centage Charges in percentage in the Proposal Form given in Annexure to this RFP. The selection of the Accredited Agency will be done based on parameters as envisaged in Para 6 of GO (P) 67/2021/Fin dated. 28/04/2021. While quoting the Non PMC Charges, the relevant clauses in the above said GO may be adhered to.

16. General Conditions of Contract application:

The General Conditions shall apply to the extent those provisions in other parts of the contract do not supersede them. For the interpretation of any clause in the request for proposal (RFP) or contract Agreement, the interpretation of the Department shall be final and binding on the applicant/ consultant.

17. Standards of Performance:

The bidder shall perform the services and carry out their obligations under the contract with due diligence, efficiency and economy in accordance with the generally accepted professional standards and practices. The bidder shall always act in respect of any matter relating to this contract as faithful advisor to the Government of Kerala and they shall always support and safeguard the legitimate interest of Government of Kerala in handling the project. The Bidder shall abide by the provisions/ acts/ rules etc. prevalent in the country.



18. Applicable Law

Applicable Law means the laws and any other instrument having the force of law in India as they may be issued and are in force from time to time. The contract shall be interpreted in accordance with the laws of the Union of India. For jurisdiction regarding this RFP, **the Court situated in Palakkad alone will have jurisdiction with regard to the Contract**

19. Termination of Association with the Department

The Department may terminate the contact in the following ways:

- The terms of contract expires.
- Termination of contract by PWD due to non-performance during the engagement period.
- Non-adherence to the timelines of the assignment.

20. Documents to be submitted along with the Proposal

1. The Completely filled-up proposal in Official letter head in the format given in A1 annexure, duly signed and official stamp affixed.
2. The bidder shall submit one complete set of original RFP and each page of the proposal document should be duly signed by the Authorized Signatory of the bidder agency in token of acceptance of the terms & conditions of this RFP document.
3. Valid documents (Government Orders) to prove their validity to take up Public Works as Government Accredited Agencies in Non PMC mode for the General Civil Construction Works category.
