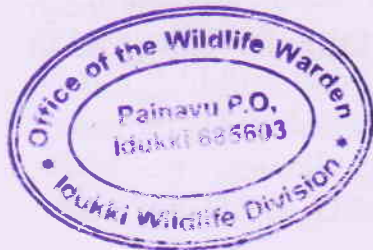

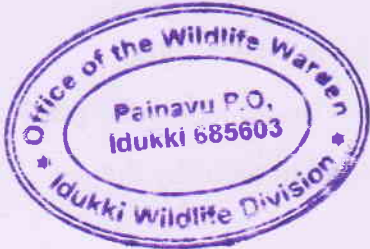

#### **4 OBJECTIVES OF RFP**

The work **“Construction of physical barriers for mitigating man-animal conflict in Idukki Wildlife Sanctuary in Idukki District and Thattakkad Bird Sanctuary in Ernakulam district under Wildlife Circle, Kottayam under NABARD-RIDF-Tranche-XXX Scheme”** includes the construction of 11.70 Km Hanging solar fencing and 17.07 Km elephant proof trench in two PAs (Idukki & Thattakkad Sanctuaries) under Wildlife Division Idukki in Kerala Forest Department at different locations in Idukki and Ernakulam districts. Since the proposed work is to be executed in PMC mode as per GO (P) 67/2021/Fin dated.28/04/2021, the bidders may inspect the site, do proper required survey and collect required measurements and prepare detailed estimate. Measurement marking and estimate preparation are to be done strictly following the Kerala PWD work manual and final estimate should be prepared and submitted using Kerala PWD PRICE software following the latest approved CPWDDSR.

The bidder should quote other charges like Centage charges, Welfare Fund Contributions, GST, IT, Cess etc. on Government approved rates along with submission of the proposals, but those are to be substantiated through valid Government orders or Acts.

## 6. TIMELINE FOR THE ASSIGNMENT

The entire work has to be completed within period of 24 months from the date of signing of the work agreement.

## 7. ELIGIBILITY

## **8 PERIOD OF VALIDITY OF PROPOSALS**

*Proposals shall remain valid for 300 days from the date of opening prescribed by the Purchaser. A PROPOSAL FOR A SHORTER PERIOD VALIDITY SHALL BE REJECTED BY THE PURCHASER AS NON-RESPONSIVE BID.* In exceptional circumstances, the Purchaser may request the Bidder's consent for an extension to the period of validity. The requests and the responses therefore shall be made in writing.

## **9 FORMAT AND SIGNING OF PROPOSAL**

The bidder shall submit one complete set of original RFP/EOI and all the pages of RFP/EOI shall be signed by the bidder or a person or persons duly authorized to bind the bidder to the contract. The proposals shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be authenticated by the person or persons signing the proposals.

## **10 SUBMISSION OF PROPOSALS**

**RIGHT TO ACCEPT ANY RFP AND TO REJECT ANY OR ALL PROPOSALS:** Wildlife Warden, Wildlife Division, Idukki reserves the right to accept or reject any proposals, and to annul the bidding process and reject all proposals, at any time without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

**11. CLARIFICATION OF PROPOSALS:** To assist in the examination, evaluation and comparison of Proposals, the Department may, at its discretion, ask the bidder for the clarification of its proposals. The request for the clarification and the response shall be in writing. However, no clarifications post proposal opening at the initiative of the bidder shall be entertained. Purchaser shall evaluate the proposals in detail as per the conditions of the RFP/EOI document.

**12. SEALING AND SUBMISSION:** Duly signed proposal document along with necessary documents in support of the qualification and Preliminary agreement in Rs.200/- stamp paper shall be enclosed in an envelope super scribed with name of work, sealed and delivered to the address as below on or before the last date and time of submission.

RFP shall be submitted in two separate sealed cover.

(a) The technical proposal of the entity should include the profile of the organization, organizational structure, the details of ongoing and completed projects, experience certificates, type of firm, date of incorporation, human resources employed by the entity, annual turnover of the entity etc. which shall be placed as technical bid document and sealed in separate cover.

***(b) The financial quote of the towards installation of Hanging Solar Fencing and digging Elephant Proof Trench shall be placed as a financial bid and sealed in separate cover.***

### **13. SELECTION AND DECLARATION OF SUCCESSFUL BIDDER**

Selection will be made purely on the basis of lowest quote subject to the condition that the qualification, technical, viability and experience of the applicant is satisfactory. The cost shall include all taxes as per prevailing rules and statutory recoveries will be made as per prevailing rates. The service includes all fee payable to various departments, documentation charges, certification costs, sundry expenses, overheads etc.



#### **14. GENERAL CONDITIONS OF CONTRACT**

**APPLICATION:** The General Conditions shall apply to the extent those provisions in other parts of the contract do not supersede them. For the interpretation of any clause in the Request for Proposal (RFP) /EOI or contract Agreement, the interpretation of the Department shall be final and binding on the applicant/consultant.

**15 .STANDARDS OF PERFORMANCE:** The Bidder shall perform the services and carry out their obligations under the contract with due diligence, efficiency and economy in accordance with the generally accepted professional standards and practices. The Bidder shall always act in respect of any matter relating to this contract as faithful advisor to the Government of Kerala and they shall always support and safeguard the legitimate interest of Government of Kerala in handling the project. The Bidder is bound to follow all relevant Government Orders, Circulars, Kerala PWD Manual, Forest Acts and Rules made there under etc. prevailing even though specific reference to those are not provided elsewhere in the contract condition.

**16. APPLICABLE LAW:** Applicable Law means the laws and any other instrument having the force of law in India as they may be issued and in force from time to time. The contract shall be interpreted in accordance with the laws of the Union of India.
