

#### **CONDITIONS**

1. Bidders shall remit the e-tender document fee and the Earnest Money Deposit using online payment option of e-procurement system only and submitted through the internet online banking of State Bank of India or through NEFT for other banks. Bidders opting for NEFT facility of online payment are advised to exercise this option at least 48 hours before the closing date of bid to ensure that payment towards tender document fees and EMD are credited and a confirmation is reflected in the e-procurement system. The online NEFT remittance form provided by e-procurement system for making a NEFT transaction is not a payment confirmation. Kerala Forest Department/NIC/ SBI shall not be responsible for any kind of delay in payment status confirmation.
2. The contractor must have a valid PWD Electric License.
3. Bidders are requested to submit scanned copy of the following documents - Registration certificate duly attested by the Superintending Engineer/ Executive Engineer, PWD Kerala, GST Registration certificate, PAN, Bank details, EMD exemption certificate (if any), preliminary agreement executed in Kerala Stamp paper worth Rs.200/-, duly filled up proforma for availing e-payment by Online. Technical bid and financial bid shall be submitted in their respective designated online covers. Subsequently the hard copy of attested copy of Registration certificate, EMD exemption certificate (if any), preliminary agreement in original, proof of prequalification etc. would be submitted offline in a sealed cover super scribing the name of work and tender number to the office of the Divisional Forest officer, Achencovil through speed post / registered post as prescribed in the time schedule, failing which such tenders will be rejected.
4. The bidding authority deserves the right to modify / cancel any / all bids without assigning any reason. The Forest Department will not be responsible for any error like missing of scheduled data while downloading by the bidder and non-receipt of documents.
