The acceptance of the quotations will be subject to the following conditions:

 Acceptance of the quotation constitutes a concluded contract. The successful renderer must within 7 days after the acceptance of his quotation furnish 5 per cent of the amount of the contract as security deposit in the form of Treasury Saving Bank deposit pledged in the name of undersigned and execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required.

- 2. Withdrawal from the quotation after it is accepted or failure to completing the work within the specified time or according to specifications will entail cancellation of the order and any loss incurred thereby being payable by the defaulting party.
- 3. No representation for enhancement of rate quoted once accepted will be considered during the currency of the contract.
 - 4. Any attempt on the part of renderers or their agents to influence the Officers concerned in their favor by personal canvassing will disqualify the renderers.
 - 5. The renderer should have C class Forest Contractor License for participating the in quotation.
 - 6. The quotation may be for the entire work.
 - 7. (a) In cases where a successful renderer, after having made partial work fails to fulfill the contracts in full, all or any of the materials not supplied may, at the discretion of the Purchasing Officer be purchased by means of another tender/quotation or by negotiation or from the next higher renderer who had offered to supply already and the loss, if any, caused to the Government shall thereby together with such sums as may be fixed by the Government towards damages be recovered from the defaulting renderer.
 - a. (b) Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.
 - b. (c) Any sum of money due and payable to the contractor (including Security Deposit returnable to him) under this contract may be appropriated by the Purchasing Officer or Government or any other person authorized b Government and set-off against any claim of the Purchasing Officer or Government for the payment of a sum of money arising out of or under any other contract made by the contractor with the Purchasing Officer or Government or any other person authorized by Government.
 - 8. Payments will be made only after completion of the works and verification.
 - 9. The renderers shall quote the percentage of rebate (discount) offered by them in the quotation itself.
 - 10. Any sum of money due and payable to the successful tenderer or contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
