Successful bidders will have to remit the balance value ,GST,FDT,IT and other taxes prevailing at the time of e-auction within the stipulated time limit.

## **Sale Conditions**

- 1. Intending Tenderers/Bidders should deposit an Earnest Money Deposit of Rs.25000/- as online / Demand Draft drawn in favour of The Divisional Forest Officer, Thiruvananthapuram from any Nationalized Bank for participating in the e-auction.
- 2. The successful Tenderers / Bidders should remit 35% of the bid value through e-treasury system within 7 working days of issuance of acceptance letter if the balance amount is greater than one lakh.. If the successful bidder fails to remit this amount within the prescribed time, the EMD will be forfeited to Government and the lots will be re-auctioned at his risk and loss.
- 3. The successful Tenderers/Bidders have to pay 1/3<sup>rd</sup> balance value, GST (as per Rule), FDT, Income Tax and other taxes if any at the rate prevailing from time to time within 15 days of issuance of acceptance letter.
- 4. The e-auction will be on lump-sum basis for the right of felling, collection and removal of entire marked and enumerated tree species only from the above area mentioned in the schedule hereto the area of which has been surveyed and demarcated on the ground.
- 5. Intending tenderers/bidders may inspect the trees themselves of the quality and quantity of the produce before participating in the auction. Complaints if any, regarding the quality and quantity etc. received after the e-auction will not be entertained.
- 6. If the value fetched in the resale/re-e-auction is less than that obtained in the original e-auction, the difference between them together with all incidental expenditure to fixing up of the resale including notification charges as assessed by the Divisional Forest Officer concerned will be recovered from the defaulting Tenderers/Bidders through legal means including Revenue Recovery Act in force.
- 7. The participating Tenderers/Bidders only have the rights for the felling, collection and removal of marked and enumerated standing trees and they have no right for felling, collection and removal of unmarked softwood trees as well as Hardwood trees like, Rosewood, Sandal, Irul etc, if any.

- 8. The successful Tenderers/Bidders should execute a bounden agreement on a stamp paper worth Rs.200/- after completion of e-auction.
- 9. The confirmation of the e-auction sale will ordinarily be communicated to the party concerned as early as possible. Within 15 days from the date of issue of acceptance letter, the successful tenderers/Bidders should execute an agreement on a stamp paper worth rupees equal to an amount, 0.1% of the total Sale value, after remitting 1/3<sup>rd</sup> of the balance sale value and 5% Forest Development Tax, GST (as per Rule) and Income Tax at the rate in force and security deposit of 10% for the total sale value. In case of failure to remit the amount within 15 days extension shall be granted by the Divisional Forest Officer for 15 days subject to the realization of 12% penal interest. Further extension for 15 days shall be granted by the Divisional Forest Officer subject to the realization of 24% penal interest. In case of failure to remit the amount within the extended period, further extension for 15 days by the Chief Conservator of Forests, Souther circle, Kollam and 15 days by the Principal Chief Conservator of Forests (Forest Management) shall be granted subject to the realization of penal interest at 24% and 48% respectively. But all the extension periods mentioned above will be within the original contract period.
- 10. The balance 2/3<sup>rd</sup> sale value should be remitted in two equal installments by the successful Tenderers/Bidders. The first installment should be remitted within 15 days from the date of agreement and the second installment within 30 days from the date of agreement or within the contract period whichever is earlier. If the successful Tenderers/Bidders fails to remit the above amount within the period mentioned above, extension for 15 days by realizing penal interest at 12% by the Divisional Forest Officer concerned, extension for 30 days by realizing penal interest at 24% by the Chief Conservator of Forests concerned and further extension for 30 days by the Principal Chief Conservator of Forests concerned by realizing penal interest at 48% shall be granted respectively. But all the above extended periods will be within the original contract period.
- 11. The period of contract will be 30 days (thirty days) from the date of execution of Agreement. No extension of the period of contract shall normally be granted on any ground. Under very special circumstances, for good and sufficient reasons, the Divisional Forest Officer may take necessary decisions for grant extension of time.

- 12. The license for the removal of timber and firewood collected from the coupe should be issued only on the basis of the prevailing norms.
- 13. The contractor or his agent shall enter into the coupe only after getting the written permission from the Divisional Forest Officer, Thiruvananthapuram or Range Forest Officer, Paruthippally
- 14. The contractor shall at all time during the currency of the contract, keep the boundaries cleared to a width of 2 meters and keep the cairns intact.
- 15. The contractor will be liable for any damage or loss caused to other trees in the nearby plantations, if any or in the reserve.
- 16. The Divisional Forest Officer will give permission to keep the timber and other produce outside the coupe, if requested by the contractor at his own risk. But, if the collected timber/firewood are not removed within the agreement period due to unforeseen situation or climate, a ground rent @Rs.250/- per hectare will be recovered from the tenderer/bidder concerned.
- 17. The tenderer/bidder will be liable for all the illegal activities occurred within 0.4 km perimeter of the above mentioned area. Any such activities noticed should be reported to the forest officials by the contractor, otherwise the contract will be cancelled.
- 18. The security deposit will be refunded only after the successful completion of the Agreement conditions after producing the clearance certificates of Sales Tax, Income Tax, Agricultural Income Tax etc... If there is any liabilities outstanding in this respect to the government, that will be adjusted from the security deposit of the contractor.
- 19. All common conditions regarding sale coupes are also applicable to this e-auction. Further details can be had from the office of the undersigned or from the office of the Range Forest Officer, Paruthippally on all working days
