- 4. The Accredited Agency selected in the bid should conduct investigation, (including soil investigation) planning, design, preparation of drawings,

detailed estimate and preparation of Detailed Project Report (DPR) within 7 days from the date of agreement in the format attached in Annexure 1.

5. The Accredited Agency selected should prepare tender documents issue of tender notification including advertisement charges, evaluation of tender award of work and execution of contract, supervision, quality control, measurement, check measurement, preparation and passing of contract bills after getting approval of DPR.

6. The Undersigned is authorised to cancel the bid at any point of time without assigning any reason thereof in case of any dispute.

II. Write up of DPR

- 1. Index (Contents)
- Executive Summary of the Project -A nut shell description of the project in a single page
- 3. A detailed description of the project, contains
 - i. Background of the project
 - ii. Objectives of the Project
 - iii. Description of the Project-Present proposal
 - iv. Necessity of the Project
 - v. Benefits of the Project (How it benefits the people, Rural economy and development)
 - vi. Time frame for the Project
 - vii. Project Finance
 - viii. Abstract of project with location and cost (Tabular Form)
 - ix. Project Implementation, Monitoring and evaluation
 - x. Conclusion
 - 4. Detailed Estimates with Data Analysis

III, Mandatory Documents to be attached with the DPR

- 1. Checklist of the project in the prescribed format of NABARD
- 2. Provisional Technical sanction (generated through PRICE 3)
- 3. Land Availability Certificate
- 4. Adequacy Certificate
- 5. General Abstract of Estimates (Generated through PRICE)
- 6. Detailed Estimates
- 7. Data analysis

IV. Preparation of Estimate

- 1. Estimates should be prepared after the site inspection and necessary soil tests if any
- 2. The estimates should be prepared in Price software only
- 3. While preparing the estimate the basic building civil works, electrification, sanitary, Plumbing, other civil nature works like septic tank, compound wall, interlock tile etc, furnishing, equipments like Solar, CCTV, Fire safety etc should be included in the estimate in separate head.
- 4. NABARD defines bench mark cost for civil works every year. The current Bench Mark cost for building is 0.25 lakhs per Sqm. Hence the building cost per unit area must be limited within the Bench mark cost of civil work. The building cost per unit area is calculated excluding electrification, sanitary, drinking water and other civil nature works, equipments etc. The same is applicable to road works also.
 - Provision for GST and Centage charges for accredited agencies should be included as per the prevailing rate

Annexure II a, II b and III are to be submitted with the DPR. These annexures are the nutshell of the DPR. Hence the preparation of these annexures is very important. The entire field in the annexures have to be filled carefully and no column should be left blank. The documents in a DPR have to be arranged in the following manner:
