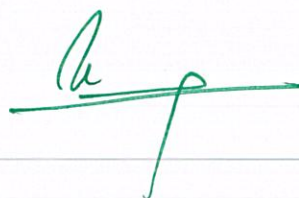
3. Definitions

Unless the context otherwise requires, the following terms wherever used in this RFP have the following meanings:

- A. **"Applicable Law"** means the laws and any other instruments having the force of law in India as they may be issued and in force from time to time.
- B. **"Proposals"** means proposal submitted by respondents in response to the RFP issued by the Department.
- C. **"Contract"** means the Contract signed by the parties for the project along with the entire documentation specified in the RFP.
- D. **"Day"** means Calendar Day
- E. **"Department"** means authorized officer of Kerala Forest Department, Government of Kerala
- F. **"Services"** means the work to be performed by the Accredited Governmental Agency pursuant to the contract to be signed by the parties in pursuance of any specific assignment awarded to them by the Department.
- G. **"The Bidder"** Means the entity which participates in the RFP and submits its proposals.
- H. **"The Purchaser"** means authorized officer of Kerala Forest Department, Government of Kerala

4. Objectives of RFP

Thiruvananthapuram Forest Division is comprised of three ranges namely Paruthippally, Palode and Kulathupuzha with Head Quarters at Thiruvannanthapuram. Since the boundary of the Forest Division is very large, a good part of the division is forest area which is home to large variety of plants and animals showing the vast richness of our mother nature. However, the other part of the fact is that there are a lot of places within the division which are home land to traditional tribal settlements, but are very close to animal ecosystem as well. The friction between humans and wildlife, known as human-wildlife conflict, is a significant problem in Thiruvananthapuram division. This conflict arises when wildlife's needs or



behaviours negatively affect humans, or when human activities adversely impact wildlife. The causes behind these conflicts are multifaceted and complex. Both the wild animals as well as the human beings are to be protected without harming each others. To tackle human-wildlife conflicts and ensuring the well being of forest dwellers and those residing in forest fringes, as a permanent measure to prevent wild animals from venturing out of forest, claiming human lives and causing extensive crop damage, Thiruvananthapuram Forest Division has proposed to Install and Commission Normal solar power fencing and smart over 10.6km in various sites of Paruthippally and Kulathupuzha ranges during 2026-27 as part 100days programme of Kerala Government and for preventing wild animals from straying into human habitations. Wild animals, especially elephants and wild boar enter habitations resulting in conflicts despite various steps being taken to prevent such incidents. Hence this project fruitfully tackle the issues.

This RFP is called for among accredited agencies under Finance Department, Government of Kerala classified as Project Management Consultant (PMC) to technically assist the Department in preparation of estimate, selection of competent contractor, supervision of the work during execution, certification of the work in terms of quality and quantity and preparation of all documents in connection with work as per PWD rules.

5. Description of Project

A smart solar fence is an advanced security or agricultural system that combines solar power with intelligent monitoring features like automatic day/night switching, fault detection alarms, and safe high-voltage deterrent pulses.

The Normal solar power fencing and (smart) is more successful at areas where the main threat is from elephants than from other animals. It is sufficient to prevent them from entering to the human inhabited area and agricultural land of tribes. It is an innovative technology this can help to prevent incidents like crop raiding and attacks on humans.

6. Scope of Work

The department intends to award the work as a turnkey project which involves the complete aspects of the projects. The work include Installing and Commissioning of Normal solar power fencing and smart over 10.6km in various sites of Paruthippally and Kulathupuzha ranges during 2026-27 as part 100days programme of Kerala Government



The bidders may inspect the site, do proper requirement survey and collect required measurements and detailed estimate is to be provided. Measurement marking and estimate preparation are to be done strictly following the Kerala PWD work manual and final estimate should be prepared and submitted using Kerala PWD PRICE software following CPWD DSR2021 rate schedule.

The bidder should quote other charges like Centage charges, Welfare fund contributions, cess etc on Government approved rates, but those are to be substantiated through valid Government orders or Acts along with submission of the proposals.

7. Background of the project

To mitigate Man Animal Conflict thereby protect both humans as well as elephant populations, fostering harmonious coexistence between humans and elephants and to the whole ecosystem

10. Timeline for the assignment

The site survey and final estimate submission has to be completed within a period of 10 days from the date of selection of the accredited agency. Upon approval of the estimate by the technical committee, the whole tender process and selection of the competent contractor for the execution shall be completed within 10 days from the approval of the estimate.

11. Eligibility

The applicant has to be an accredited agency under Finance Department, Government of Kerala for execution of public works.

12. Period of Validity of Proposals

Proposals shall remain valid for **45 days** from the date of opening prescribed by the Purchaser. A **PROPOSAL FOR A SHORTER PERIOD VALIDITY SHALL BE REJECTED BY THE PURCHASER AS NON-RESPONSIVE BID**. In exceptional circumstances, the Purchaser may request the Bidders consent for an extension to the period of validity. The requests and the responses there for shall be made in writing.

13. Format and signing of Proposal

The bidder shall submit one complete set of original RFP and all the pages of RFP shall be signed by the bidder or a person or persons duly authorized to bind the bidder to the contract. The proposals shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be authenticated by the person or persons signing the proposals.

14. Submission of Proposals

The proposals should reach the office of the Divisional Forest Officer, Forest Headquarters, Kerala Forest Department, Vazhuthacaud, Thycaud P.O Thiruvananthapuram before the closing time mentioned at Paragraph 2.1 above and the proposals received after this specified time will not be accepted



15. RIGHT TO ACCEPT ANY REP AND TO REJECT ANY OR ALL PROPOSALS:

The Divisional Forest Officer, Thiruvananthapuram Division reserves the right to accept or reject any proposals, and to annul the bidding process and reject all proposals, at any time without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

16. CLARIFICATION OF PROPOSALS:

To assist in the examination, evaluation and comparison of Proposals, the Department may, at its discretion, ask the bidder for the clarification of its proposals. The request for the clarification and the response shall be in writing. **However, no clarifications post proposal opening at the initiative of the bidder shall be entertained.** Purchaser shall evaluate the proposals in detail as per the conditions of the RFP document.

17. SEALING AND SUBMISSION:

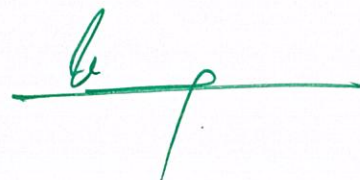

The cost shall include all Taxes as per prevailing rules and statutory recoveries will be made as per prevailing rates. The service includes all fee payable to various departments, documentation charges, certification costs, sundry expenses, overheads etc.



19. General Conditions of Contract

APPLICATION:

21. APPLICABLE LAW

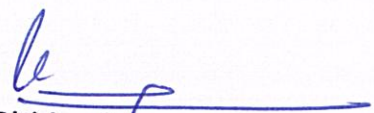
