TERMS OF REFERENCE

Duties and Responsibilities:

1. Treatment of different medical emergencies of wild animals at the site of detection.
2. Curative treatment to sick/injured wild animals.
3. Chemical immobilization and capture of wild animals as approvals received from competent authority,
4. Early detection of communicable and non-communicable diseases and epidemics in wild populations.
5. To help RRT and section staff for rescue & rehabilitation of wild animals upon straying into human habitation at times of need.
6. Collection of both ante mortem & postmortem samples and their subsequent delivery to referral laboratory for further diagnosis.
7. To perform different Departmental activities in connection with Human Wildlife Conflict, as per the direction of Chief Conservator of Forests, Northern Circle and Chairman FDA, Kannur.

Terms and Conditions of Service

1. Appointment is purely on contract basis for a period of one year from the date of agreement.
2. On completion of tenure, the contract shall lapse automatically. However, the appointment can be terminated at any time (on either side) by giving one month's notice.
3. The appointee shall not be entitled to any benefits like provident fund, pension, gratuity, medical attendance treatment, seniority, promotion etc. or any other benefits available to the Government servant appointed on regular basis.
4. The appointment carries the liability to serve in any part of the Kerala as per the direction of Chief Conservator of Forests, Northern Circle and Chairman FDA, Kannur, though the main duty of the appointee will be in the districts of Kozhikode, Kannur Kasaragod and Wayanad.
5. The appointee shall perform the duties assigned to him/her. The Competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
6. During the continuance of contract period, he/she will be subject to follow the standard of discipline of the force and will execute the orders of administrative authority either written or verbal.
7. The office space of the appointee will be at Peruvannamuzhy, Kozhikode. He/She may carryout his/her office work at Human Wildlife Conflict control room in the Northern Circle office at Kannotheumchal, Kannur, as instructed by Chief Conservator of Forests, Northern Circle and Chairman FDA, Kannur.
8. Official vehicle shall be utilized for travelling in case of official requirements. The vehicle shall be arranged by Range Forest Officer, Peruvannamuzhy Range or authorized forest officials of divisions where service is required.

9. The monthly contract pay of Rs. 46,230/- will be released by Divisional Forest Officer & Chief Executive Officer, Forest Development Agency, Kozhikode based on the concerned monthly attendance statement furnished by Range Forest Officer, Peruvannamuzhy Range.
10. The appointee is supposed to work for a minimum of 26 days in a month. The attendance register is to be maintained by Range Forest Officer, Peruvannamuzhy Range and certified statement to be furnished to Divisional Forest Officer & Chief Executive Officer, Forest Development Agency, Kozhikode by 3rd of every month. If the appointee is unable to work for a minimum of 26 days a month, then the proportionate amount for a day of Lump-sum pay shall be deducted for each day of absence from the contract pay.
11. As per the circumstantial need, the appointee shall attend the duty for more than 26 days to 30/31 days in a month as per direction of Chief Conservator of Forests Northern Circle, Kannur. No extra payment can be claimed for working above 26 days.
12. The appointee will be permitted to purchase safety or protection gears/outfits worth Rs.10,000/- which shall be reimbursed upon examining and production of original bills.
13. The appointee needs to work sincerely to protect and uplift the reputation of Kerala Forests and Wildlife department.
